DEPUTIZING THE BARANGAY CAPTAINS OF KATIPUNAN, ZAMBOANGA DEL NORTE AS FOREST OFFICERS OF THE MINISTRY OF NATURAL RESOURCES.

Pursuant to Section 20 of Presidential Decree No. 705, the following are hereby deputized as FOREST OFFICERS of the Ministry of Natural Resources/Bureau of Forest Development, effective upon receipt hereof, of which this Office shall be informed accordingly.

Under the authority of this deputation, they are authorized to detect violations of the laws/rules and regulations administered by the Bureau of Forest Development. In the event, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in Sections 68, 69, 70 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in the commission of the offense and the forest products cut, gathered or removed by the offender in the process of committing the offense. In all instances of detection,

... of confiscations, they shall ... period ... from the time of arrest and seizure, the offender and the confiscated products, tools and equipment too, and file the proper complaint with the state official designated by law to conduct ... investigation ... in court through the District Forester or Regional Director.



... Section 45 of PD 705, they are authorized to administer an oath ... in official matters connected with the ... of their ... to take testimony in official investigations conducted under the ... of the Revised Forestry Code of the Philippines and its implementing ... regulations.

They shall submit to the District Forester, Dipolog City ... report of the cases they have handled pursuant to this Order.

... shall be automatically revoked upon termination of their ... unless sooner terminated by this Office.
