of this delegation, they are authorized to detect violations of the  
rules and regulations administered by the Bureau of Forest Development.  
Without warrant, any person who has committed, is committing,  
or is about to commit in your presence any of the offenses defined in Sections 68, 69,  
and 70 of Presidential Decree No. 705, within your territorial jurisdiction,  
shall be authorized to seize/confiscate the tools and equipment used in  
the offense and the forest products cut, gathered or removed by the  
person process of committing the offense. In all instances of detection,


In case of seizure or confiscations, they shall deliver within the period of ten days from the time of arrest and seizure, the offender and the confiscated objects, tools and equipment too, and file the proper complaint with the official designated by law to conduct preliminary investigation and presentation in court through the District Forester or Regional Director.

Under Section 45 of PD 705, they are authorized to administer an oath or affirmation in official matters connected with the functions of their office, give testimony in official investigations conducted under the Revised Forestry Code of the Philippines and its implementing regulations.

They shall submit to the District Forester, Dipolog City a report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their office unless sooner terminated by this Office.


