of this denaturalization, they are authorized to detect violations of the
 rules and regulations administered by the Bureau of Forest Development
 without warrant, any person who has committed, is committing
 in your presence any of the offenses defined in Sections 48, 49,
 of Presidential Decree No. 705, within your territorial jurisdiction
 authorized to seize/confiscate the tools and equipment used in
 the offense and the forest products cut, gathered or removed by the
 process of committing the offense. In all instances of detection,

... seizures or confiscations, they shall deliver within the period ... from the time of arrest and seizure, the offender and the confis- ... cations, tools and equipment too, and file the proper complaint with, ... official designated by law to conduct preliminary investigation ... in court through the District Forester or Regional Direct.


... Section 45 of PD 705, they are authorized to administer an oath ... in official matters connected with the functions of their ... testimony in official investigations conducted under the ... the Revised Forestry Code of the Philippines and its implementing ... tions.

... shall submit to the District Forester, Dipolog City ... report of the cases they have handled pursuant to this Order.

... deputation shall be automatically revoked upon termination of their ... office unless sooner terminated by this Office.
