In the course of this deputation, they are authorized to detect violations of the laws/rules and regulations administered by the Bureau of Forest Development. They may arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in Sections 66, 69, 70 and 71 of Presidential Decree No. 705, within your territorial jurisdictions. They shall be authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the persons during the process of committing the offense. In all instances of detection,


and/or seizure or confiscations, they shall deal with the period limited by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with, appropriate official designated by law to conduct preliminary investigation of the information in court through the District Forester or Regional Director.


Pursuant to Section 45 of PD 705, they are authorized to administer an oath of acknowledgement in official matters connected with the functions of their office to take testimony in official investigations conducted under the Revised Forestry Code of the Philippines and its implementing regulations.

They shall submit to the District Forester, Liloy, Zamboanga del Norte report of the cases they have handled pursuant to this Order.

Their reputation shall be automatically revoked upon termination of their service unless sooner terminated by this Office.
