In victue of this deputation, they are authorized to detect violations of the thresing laws/rules and regulations administered by the Burcau of Forest Development to arrest, even without warrant, any person who has committed, is committing or apout to commit in your presence any of the offenses defined in Sections 68, 69, , 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. may are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offerences in the process of committing the offense. In all instances of detection,

For seizure or confiscations, they shall deliver within the period

by law from the time of arrest and seizure, the offender and the confis
ent products, tools and equipment too, and file the proper complaint with,

respirate official designated by law to conduct preliminary investigation

the information in court through the District Phrester or Regional Director.

Forsuart to Section 45 of PD 705, they are authorized to administer an oath take acknowledgement in official matters connected with the functions of their take, and to take testimony in official investigations conducted under the hority of the Revised Forestry Code of the Philippines and its implementing less and regulations.
