**ACT : Deputizing the Barangay Captains of Bilar, Bohol as Forest Officers of the Ministry of Natural Resources.**

Pursuant to Section 80 of Presidential Decree No. 705, the following are deputized as FOREST OFFICERS of the Ministry of Natural Resources/Bureau of Forestry, effective upon receipt hereof, of which this Office shall be recording.

In this Deputation, they are authorized to detect violations of the rules and regulations administered by the Bureau of Forestry... In all instances of arrest and/or seizure or confiscations, they shall deliver the same prescribed by law from the time of arrest and seizure, the offender and forest products, tools and equipment too, and file the proper...

with, the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath of acknowledgement in official matters connected with the functions of their office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.


They shall submit to the District Forester, Tagbilaran City a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their term of Office unless sooner terminated by this Office.
