SUBJECT : Deputizing the Barangay Captains of Godod,

By virtue of this deputation, they are authorized to detect violations of the  
forestry laws/rules and regulations administered by the Bureau of Forest Development  
to arrest, even without warrant, any person who has committed, is committing or  
about to commit in your presence any of the offenses defined in Sections 68, 69,  
71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions.  
They are also authorized to seize/confiscate the tools and equipment used in  
committing the offense and the forest products cut, gathered or removed by the  
offender/s in the process of committing the offense. In all instances of detection,

... seizure or confiscations, they shall deliver within the period  
... by law from the time of arrest and seizure, the offender and the confis-  
... products, tools and equipment too, and file the proper complaint with,  
... official designated by law to conduct preliminary investigation  
... information in court through the District Forester or Regional Director.


... to Section 45 of PD 705, they are authorized to administer an oath  
... acknowledgement in official matters connected with the functions of their  
... to take testimony in official investigations conducted under the  
... of the Revised Forestry Code of the Philippines and its implementing  
... regulations.

They shall submit to the District Forester, Liloy, Zamboanga del Norte  
... report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their  
... of office unless sooner terminated by this Office.
