
with, the appropriate official designated by law to conduct every investigation and file the information in court through the District Forester, Regional Director.

Under Section 45 of PD 705, they are authorized to administer an oath of acknowledgement in official matters connected with the functions of their office and to take testimony in official investigations conducted under the provisions of the Revised Forestry Code of the Philippines and its implementing rules and regulations.


They shall submit to the District Forester, Tagbilaran City a report of the cases they have handled pursuant to this Order.

Their reputation shall be automatically revoked upon termination of their office unless sooner terminated by this Office.
