In all instances of detection

rit and/or seizure or confiscations, they shall deliver within the period nited by law from the time of arrest and seizure, the offender and the confisco forest products, tools and equipment too, and file the proper complaint with, appropriate official designated by law to conduct preliminary investigation of file the information in court through the District Forester or Regional Director.

Firsuant to Section 45 of PD 705, they are authorised to administer an oath the acknowledgement in official matters connected with the functions of their test, and to take testimony in official investigations conducted under the charity of the Revised Forestry Code of the Philippines and its implementing for and regulations.
