By virtue of this deputation, they are authorized to detect violations of the firstry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or removed by the offender/s in the process of committing the offense. In all instances of detection,

cont/or seizure or confiscations, they shall deliver within the period

by law from the time of arrest and seizure, the offender and the confiscent products, tools and equipment too, and file the proper complaint with, crimopriate official designated by law to conduct preliminary investigation

file the information in court through the District Forester to Regional Director.

Fursuant to Section 45 of PB 705, they are authorited to acclaister an oath take acknowledgement in official matters connected with the functions of their clos, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing class and regulations.

They shall submit to the District Forester, Real, Quezon a control report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their of office unless sooner terminated by this Office.
