is about to commit in your presence any of the offenses defined in Sections 1 to 10 of  
Presidential Decree No. 705, within your territorial jurisdiction and  
confiscate the tools and equipment used  
in the commission of the offense.


with, the appropriate official designated by law to conduct investigation and file the information in court through the District Regional Director.


In accordance to Section 45 of PD 705, they are authorized to administer oaths or acknowledgement in official matters connected with the functions of the Office and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its Implementing Rules and regulations.

I shall submit to the District Forester, Tagbilaran City a report of the cases they have handled pursuant to this Order.

The reputation shall be automatically revoked upon termination of their service unless sooner terminated by this Office.
