SUBJECT : Deputizing the Barangay Captains of Pilar, Cebu as Forest Officers of the Ministry of Natural Resources.

Pursuant to Section 80 of Presidential Decree No. 705, the following are deputized as FOREST OFFICERS of the Ministry of Natural Resources/Bureau of Forest Development, effective upon receipt hereof, of which this Office shall be recording accordingly.

... of this deputation, they are authorized to detect violations of ... laws/rules and regulations administered by the Bureau of Forest ... and to arrest, even without warrant, any person who has committed, is ... or is about to commit in your presence any of the offenses defined in ... 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your ... jurisdictions. They are also authorized to seize/confiscate the tools ... used in committing the offense and the forest products cut, gathered ... by the offender/s in the process of committing the offense. In all ... of detection, arrest and/or seizure or confiscations, they shall deliver ... the period prescribed by law from the time of arrest and seizure, the offender ... confiscated forest products, tools and equipment too, and file the proper

in accordance with, the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take the acknowledgement in official matters connected with the functions of their office, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.


They shall submit to the District Forester, Cebu City a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their term of Office unless sooner terminated by this Office.
