virtue of this deputation, they are authorized to detect violations of
laws, rules and regulations administered by the Bureau of Forest
to arrest, even without warrant, any person who has committed, is
about to commit in your presence any of the offenses defined in
Sections 69, 70, 71 and 77 of Presidential Decree No. 705, within your
jurisdictions. They are also authorized to seize/confiscate the tools
used in committing the offense and the forest products cut, gathered
or in the process of committing the offense. In all

... preliminary investigation and file the information in court through the ...
... Director or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath
and take acknowledgement in official matters connected with the functions of their
office, and to take testimony in official investigations conducted under the
authority of the Revised Forestry Code of the Philippines and its implementing
rules and regulations.


They shall submit to the District Forester, Cebu City
a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their
tenure of Office unless sooner terminated by this Office.
