In virtue of this deputation, they are authorized to detect violations of forestry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in Sections 69, 70, 71 and 77 of Presidential Decree No. 705, within your respective jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or stored by the offender/s in the process of committing the offense. In all cases of detection, arrest and/or seizure or confiscations, they shall deliver the offender/s within the period prescribed by law from the time of arrest and seizure, the offender/s, the confiscated forest products, tools and equipment too, and file the proper




