Deputizing the Barangay Captains of Tuburan, Cebu as Forest Officers of the Ministry of Natural Resources.

Pursuant to Section 80 of Presidential Decree No. 705, the following are deputized as FOREST OFFICERS of the Ministry of Natural Resources/Bureau of Forest Development, effective upon receipt hereof, of which this Office shall be advised accordingly.

By virtue of this deputation, they are authorized to detect violations of forestry laws/rules and regulations administered by the Bureau of Forest Development and to arrest, even without warrant, any person who has committed, in violation of Sections 19, 20, 21 and 22 of Presidential Decree No. 705, within your respective jurisdictions. They are also authorized to seize/confiscate the tools and equipment used in committing the offense and the forest products cut, gathered or stored by the offender/s in the process of committing the offense. In all cases of detection, arrest and/or seizure or confiscations, they shall deliver the same as prescribed by law from the time of arrest and seizure, the offender/s and the confiscated forest products, tools and equipment too, and file the proper


...with, the appropriate official designated by law to conduct  
... investigation and file the information in court through the District  
... Regional Director.


Pursuant to Section 45 of PD 705, they are authorized to administer an oath  
... acknowledgement in official matters connected with the functions of their  
... , and to take testimony in official investigations conducted under the  
... of the Revised Forestry Code of the Philippines and its implementing  
... and regulations.

They shall submit to the District Forester, Cebu City  
... monthly report of the cases they have handled pursuant to this Order.
