By virtue of this deputation, they are authorized to detect violations of mothy laws/rules and regulations administered by the Bureau of Forest mount and to arrest, even without warrant, any person who has committed, is anger is about to commit in your presence any of the offenses defined in any 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your brain: jurisdictions. They are also authorized to seize/confiscate the tools intent used in committing the offense and the forest products out, gathered to both the offender/s in the process of committing the offense. In all and detection, arrest and/or seizure or confiscations, they shall deliver the period prescribed by law from the time of arrest and seizure, the offendative confiscated forest products, tools and equipment too, and file the proper

The planet with, the appropriate official designated by law to conduct publitinary investigation and file the information in court through the District Property or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath of take asknowledgement in official matters connected with the functions of their lice, and to take testimony in official investigations conducted under the sutherity of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Tagbilaran City monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their xr of Office unless sooner terminated by this Office.
