By virtue of this deputation, they are authorized to detect violations of
the law rules and regulations administered by the Bureau of Forest
and to arrest, even without warrant, any person who has committed, is
committing or is about to commit in your presence any of the offenses defined in
Sections 68, 69, 70, 71 and 77 of Presidential Decree No. 705, within your
jurisdictional jurisdictions. They are also authorized to seize/confiscate the tools
and equipment used in committing the offense and the forest products cut, gathered
or stored by the offender/s in the process of committing the offense. In all
cases of detection, arrest and/or seizure or confiscations, they shall deliver
within the period prescribed by law from the time of arrest and seizure, the offender
and the confiscated forest products, tools and equipment too, and file the proper


... with, the appropriate official designated by law to conduct
... investigation and file the information in court through the District
... or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath
... acknowledgement in official matters connected with the functions of their
... and to take testimony in official investigations conducted under the
... of the Revised Forestry Code of the Philippines and its implementing
... and regulations.


They shall submit to the District Forester, Tagbilaran City
