cartue of this deputation, they are authorized to detect violations of the tir; laws/rules and regulations administered by the Bureau of Forest Development to arrest, even without warrant, any person who has committed, is committing or boot to commit in your presence any of the offenses defined in Sections 68, 69, if and 77 of Presidential Decree No. 705, within your territorial jurisdictions, we are also authorized to seize/confiscate the tools and equipment used in Decree No. 11 and 12 offense and the forest products cut, gathered or removed by the iffender/s in the process of committing the offense. In all instances of detection,

or it is for seizure or confiscations, they shall deliver within the period or it d by law from the time of arrest and seizure, the offender and the confistroest products, tools and equipment too, and file the proper complaint with, appropriate official designated by law to conduct preliminary investigation file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath of take acknowledgement in official matters connected with the functions of their lee, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing testes and regulations.

They shall submit to the <u>District Forester</u>. <u>Dumaguete City</u> menthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their terms of office unless sooner terminated by this Office.
