By virtue of this deputation, they are authorized to detect violations of the restry laws/rules and regulations administered by the Bureau of Forest Development to arrest, even without warrant, any person who has committed, is committing or to commit in your presence any of the offenses defined in Sections 68, 69, 1 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. The also authorized to seize/confiscate the tools and equipment used in the offense and the forest products cut, gathered or removed by the make in the process of committing the offense. In all instances of detection,

contrast and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confineration forest products, tools and equipment too, and file the proper complaint with, the copropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Director.
