The also authorized to seize/confiscate the tools and equipment used in the offense and the forest products cut, gathered or removed by the term in the process of committing the offense. In all instances of detection,

arrest and/or seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, art file the proper complaint with, the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their effice, and to take testimony in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Ayungon, He ros Criental a mosthly report of the cases they have handled pursuant to this Order.
