By virtue of this deputation, they are authorized to detect violations of the firstry laws/rules and regulations administered by the Bureau of Forest Development is arrest, even without warrant, any person who has committed, is committing or about to commit in your presence any of the offenses defined in Sections 68, 69, 111 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. It are also authorized to seize/confiscate the tools and equipment used in thing the offense and the forest products cut, gathered or removed by the core's in the process of committing the offense. In all instances of detection,

for seizure or confiscations, they shall deliver within the period prescribed by law from the time of arrest and sei and, the offender and the confisted forest products, tools and equipment too, as file the proper complaint with, the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Regional Director.

Pursuant to Section 45 of PD 705, they are authorized to administer an oath and take acknowledgement in official matters connected with the functions of their crice, and to take testimony in official investigations conducted under the termination of the Revised Forestry Code of the Philippines and its implementing takes and regulations.

They shall submit to the District Forester, avungon, Negros Criental erentally report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their wave of office unless sooner terminated by this Office.
