In all instances of detection, prescribed by law from the time of arrest and seizule, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with, the appropriate official designated by law to condital preliminary investigation and file the information in court through the Disbrict Forester or Regional Director.
