Ty virtue of this deputation, they are authorized to detect violations of the forestry laws/rules and regulations administered by the Bureau of Forest Development to arrest, even without warrant, any person who has committed, is committing or is about to commit in your presence any of the offenses defined in Sections 68, 69, 71, 71 and 77 of Presidential Decree No. 705, within your territorial jurisdictions. To y are also authorized to seize/confiscate the tools and equipment used in permitting the offense and the forest products cut, gathered or removed by the offender/s in the process of committing the offense. In all instances of detection,

properties ord/or seizure or confiscations, they shall deliver within the period proscribed by law from the time of arrest and seizure, the offender and the confiscated forest products, tools and equipment too, and file the proper complaint with the appropriate official designated by law to conduct preliminary investigation and file the information in court through the District Forester or Pegional Director

Pursuant to Section 45 of FD 705, they are auth fixed to administer an oath aid take acknowledgement in official matters connected with the functions of their office, and to take testimeny in official investigations conducted under the authority of the Revised Forestry Code of the Philippines and its implementing rules and regulations.

They shall submit to the District Forester, Argao, Jebu a monthly report of the cases they have handled pursuant to this Order.

This deputation shall be automatically revoked upon termination of their traure of office ruless sooner terminated by this Office.
