Dear Secretary Defensor:

This refers to the request of your Department to formalize the transfer of two hundred twenty three (223) positions from the DENR- Office of the Secretary to the Environmental Management Bureau (EMB).

Pursuant to Special Provision No. 2 of Republic Act No. 9206, CY 2003 General Appropriations Act which provides that DENR shall transfer 223 regular positions, together with the corresponding budgetary allocation for the four (4) month personal services requirements of personnel presently detailed at the EMB from the DENR Office of the Secretary, we are issuing the attached Notice of Organization, Staffing and Compensation Action (NOSCA) No. 0002004-07-022 to abolish the 223 positions from the DENR - OSEC Personal Services Itemization and Plantilla of Personnel (PSIPOP).
