

I have the honour to share with you the enclosed commitments and challenges from the 2004 Tunza International Children's Conference on the Environment held in New London, Connecticut, from 19 to 23 July 2004.

The 2004 Conference was organized by the United Nations Environment Programme (UNEP) in collaboration with the International Coalition for Children and the Environment, and was sponsored by the Mashantucket Pequot Tribal Nation of Connecticut. It brought together 450 children and 250 adult chaperones from over 50 countries to share views and learn about issues related to biodiversity, indigenous peoples and the environment, water and energy. It also showcased selected environmental projects by schools and children's organizations and provided the participants with a wide range of educational workshops and field trips in the New London area.

I would be very grateful if you could share these commitments and challenges with the relevant authorities in your country. As you will see from the text, the children were strongly influenced by their interaction with the Mashantucket Pequot tribal community. I assure you that UNEP is eager to work with you in responding to these environmental challenges, which, in effect, reflect the concerns of the global community.
