

**SUBJECT : INELIGIBILITY OF "YOSHIDA CONSTRUCTION CO., LTD. TO BE AWARDED CONTRACTS FUNDED WITH JBIC ODA LOANS**

Please find herewith for your reference and guidance the letter from the Japan Bank for International Cooperation (JBIC) dated 25 December 2003 conveying the ineligibility of "Yoshida Construction Co., Ltd." to be awarded contracts funded with JBIC Official Development Assistance (ODA) Loans for the period 24 December 2003 to 23 April 2004.

Said ineligibility was imposed due to the false statements made by the said company to the Department of Tourism (DOT) on the Pre-qualification for Construction Work documents related to the Sustainable Environmental Management Project in Northern Palawan (JBIC Loan Agreement No. PH-P225).

During the four-month ineligibility period, contracts processed/concluded with Yoshida Construction Co., Ltd. either individually or as part of a joint venture intended for Japanese financing will be considered null and void by the Government of Japan.
