BY THE ANTI-ILLEGAL LOGGING TASK FORCE
SAGIP KALIKASAN OPERATION**

This is a follow through of the series of Memoranda of this office on the administrative adjudication of all apprehended illegal forest products and conveyances operated by the OSEC Anti-illegal Logging Task Force Sagip Kalikasan (TFSK) in your AOR.

It is indeed urgent to institute appropriate measures to stop the illegal logging activities specifically the transport of illegal forest products from its origin to intended destination. At the same time, it is necessary for the DENR to maintain its support network to other law enforcement agency to assist the Department in the conduct of anti-illegal logging campaign nationwide.

In this connection, you are directed to submit update/progress of all illegal forest products apprehended by OSEC-TFSK. The report should contain the status administrative adjudication consistent with the provisions of DAO 32 series of 1997 such as the forfeiture order of the confiscated forest products and the criminal complaint against the identified perpetrators. Attached for your reference are the particulars of the apprehended forest products in your respective region.

Submit your progress report with Completed Staff Work (CSW) direct to the OSEC-TFSK not later than 06 May 2005 thru telephone/fax no. 925-23-27
