- 4. Certification of actual duties and responsibilities and related experience;
- 5. Certified photocopy of college transcript and diploma;
- 6. If married, written consent of spouse; and
- 7. Duly accomplished Personal Data Sheet.
- 8. Permanent employees only

Submit the names of nominees together with the required papers (through the HRDS Director) not later than the deadline specified in each of the above mentioned course.
