

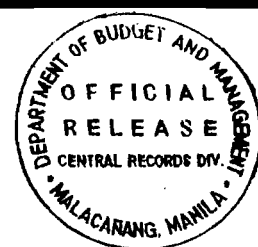

DOF-DBM JOINT CIRCULAR NO. 2 - 04
DECEMBER 16, 2004

FOR: ALL HEADS OF DEPARTMENTS, BUREAUS, COMMISSIONS, AGENCIES, OFFICES AND INSTRUMENTALITIES OF THE NATIONAL GOVERNMENT, INCLUDING GOVERNMENT-OWNED OR CONTROLLED CORPORATIONS

SUBJECT: REMINDER TO ALL DEPARTMENTS, BUREAUS, COMMISSIONS, AGENCIES, OFFICES TO IMPLEMENT THE PROVISIONS OF EO 197, DATED JANUARY 13, 2000 COVERING THE ADJUSTMENT OF FEES AND CHARGES

Fees and charges have remained a significant source of alternative revenue other than taxation. In view of the urgent need to improve revenue collection to support the level of government expenditures for vital services, and since despite EO 197, some agencies have not complied with its provisions regarding the adjustment of fees and charges to recover the cost of rendering services, this Circular is hereby issued.


Pursuant to the provisions of EO 197 (January 13, 2000) and Sec. 2 of EO 218 (March 15, 2000) which reactivated the Presidential Task Force on Fees and Charges of which the Department of Finance and Department of Budget and Management had been designated as Chair and Co-chair, respectively, all Departments, Bureaus, Commissions, Agencies of the National Government, including government-owned or controlled corporations are hereby enjoined to implement the provisions of EO 197, as provided by DOF-DBM Joint Circular No. 2000-2 (April 4, 2000).

The Bureau of the Treasury shall closely monitor the collections of fees and charges remitted by various agencies. It shall prepare a monthly report of collections based on the daily report of deposited collections submitted by authorized agent banks and compare these with the expected amount of collections submitted to the DBM. Likewise, GOCCs shall prepare a similar monthly report of collections and submit this to the Bureau of the Treasury.


