Disability-Inclusion and the COVID-19 Pandemic: Ensuring Accessibility, Equal Rights and Opportunities for All

Webinar series jointly organised by the ASEAN Disability Forum and the ASEAN Secretariat

The COVID-19 pandemic and its impacts on persons with disabilities in ASEAN

- 1. Persons with disabilities are disproportionately affected by the COVID-19 pandemic.** Around 15 per cent of the global population comprise persons with disabilities, and in Asia and the Pacific there are around 690 million persons with disabilities.¹ The pandemic is intensifying the inequalities experienced by persons with disabilities² who face significant barriers in exercising their rights throughout the lifecycle. Persons with disabilities have limited access to healthcare services brought about by lockdowns and movement restrictions. Physical distancing measures also limit access to care givers and support networks as well as access to medical, social and rehabilitation care. The resultant isolation and decreased interaction contribute to limited access to health information by persons with disabilities, which tend to magnify the marginalisation that they experience. Moreover, persons with disabilities also continue to face barriers in accessing livelihood and income support – such as access to education and training programmes.
- 2. COVID-19 and the intersectionality of gender and disabilities.** The incidence of domestic violence and abuse against women has increased during the spread of the COVID-19 pandemic³, which has a particular impact on women and girls with disabilities.⁴ Women, including women with disabilities, face limited access to reproductive health, community support services, health care, communication and information, as well as opportunities for education and employment. It is further observed that the increased demand for unpaid care and domestic work is deepening already existing inequalities⁵ which may be exacerbated for women and girls with disabilities.⁶

Persons with disabilities and the opportunities brought about by ASEAN Economic Integration

- 3. Work opportunities for persons with disabilities.** The pandemic and economic shocks increase the vulnerability of persons with disabilities. Already facing exclusion in employment⁷, persons with disabilities are more likely to lose their job and experience greater difficulties returning to work during recovery.⁸ Persons with disabilities are more likely to be in the informal economy and therefore, are not adequately covered by social protection systems. It

is reported that less than 20% of persons with severe disabilities in low and middle income countries have access to disability related social protection schemes.⁹ In addition, COVID-19 measures may indirectly affect persons with disabilities by preventing family and bread-winners of the household from working, negatively impacting the overall income of the household and increasing their vulnerability to be poor.

4. **ASEAN's commitment in promoting the rights of persons with disabilities and in mitigating the impacts of the COVID-19 pandemic in collaboration with its partners.** *The ASEAN Enabling Masterplan 2025: Mainstreaming the Rights of Persons with Disabilities* adopted in 2018 reflects the goals, aspiration and shared efforts by all ASEAN Community pillars towards an inclusive ASEAN Community by 2025. Recently, the ASEAN Ministerial Meeting on Social Welfare and Development (AMMSWD) convened a special meeting on "Mitigating the Impacts of COVID-19 on Vulnerable Groups in ASEAN", on 10 June 2020. The ministers in-charge of social welfare and development resolved to facilitate the access to social protection with appropriate allocation of public funds for social spending. This includes providing access to all essential goods and services to safeguard the well-being and livelihoods of persons with disabilities, among others, in time of crisis.
5. Ensuring the inclusion of persons with disabilities in the broader ASEAN Economic Integration agenda reinforces the paradigm shift of engaging persons with disabilities as active agents of change and contributors to inclusive economic growth. Conversely, mainstreaming their participation and facilitating the accrual of benefit would led to economic empowerment of persons with disabilities and stronger resilience to economic shocks. Towards this end, ASEAN is leveraging partnerships with China, Japan and the Republic of Korea and have reaffirmed the commitment to strengthen a coordinated response to mitigate the economic impacts of the pandemic. *The ASEAN+3 Economic Ministers' Joint Statement on Mitigating the Economic Impact of the COVID-19 Pandemic* notes the acknowledgement of the ASEAN Plus Three Countries of an urgent need for intensified and concerted efforts to address the adverse impacts of the COVID-19 pandemic on the people, financial markets and human capital. Specifically, the ASEAN Plus Three Countries expressed their commitment to support businesses, particularly the micro, small and medium enterprises (MSMEs) and the vulnerable economic sectors, and encourage them to make use of the digital economy and technologies to allow them to continue operations and repurpose their capacities to meet new needs amidst the COVID-19 pandemic.

Accessibility and all its dimensions

6. **Promotion of smart and inclusive cities in ASEAN.** Inclusive urban structure development is an integrated approach encompassing sustainable, resilient, accessible, and affordable solutions to the challenges faced by the urban poor and vulnerable groups by enhancing their access to urban services and infrastructure through targeted investments. This integrated approach encourages an institutional delivery mechanism that brings together all institutions and stakeholders—government, the private sector, and civil society—who have the capacity to deliver systems for inclusive urban service delivery.¹⁰
7. The ASEAN Smart Cities Network (ASCN) was established by the ASEAN Leaders at the 32nd ASEAN Summit held on 28 April 2018. Providing a collaborative platform for cities across the ASEAN Member States, the network intends to work together towards attaining smart and

sustainable urban development. In particular, the network aims to improve the lives of ASEAN citizens by leveraging technology and adopting inclusive approaches to smart city development. The network currently covers 26 cities working together. Currently, each smart city has developed and adopted its Smart City Action Plan (SCAP) to outline the initiatives to be undertaken towards becoming a smart city by 2025.

8. **Strengthening inclusive ASEAN Connectivity.** Connectivity in ASEAN encompasses the physical (e.g., transport, ICT, and energy), institutional (e.g., trade, investment, and services liberalization), and people-to-people linkages (e.g., education, culture, and tourism) that are the foundational supportive means to achieving the economic, political-security, and socio-cultural pillars of an integrated ASEAN Community. ASEAN Connectivity responds to emerging trends such as the doubling of the number of ASEAN households who are part of the “consuming class” over the next 15 years, movement of 90 million more people to cities within ASEAN by 2030, the need for infrastructure spending, the challenge of equipping the world’s third-largest labour force with skills, and the emergence of disruptive technologies, among others. Introducing disability-inclusion perspectives in implementing the ASEAN Connectivity agenda has the potential to introduce innovative and inclusive approaches in the built environment, which in turn ensures accessibility, mobility, and seamless movement of persons with disabilities.
9. ASEAN Connectivity 2025 aims to achieve a seamlessly and comprehensively connected and integrated ASEAN that will promote competitiveness, inclusiveness, and a greater sense of Community. The Master Plan on ASEAN Connectivity 2025 focuses on five strategic areas, namely: i) sustainable infrastructure; ii) digital innovation; iii) seamless logistics; iv) regulatory excellence; and v) people mobility.
10. To fully realise inclusive and sustainable urbanisation, it is imperative to explore pathways to introduce and integrate disability-inclusion principles and approaches in the implementation of the Master Plan on ASEAN Connectivity 2025 and the on-going work of the ASEAN Smart Cities Network. Moreover, it is equally important to ensure the substantive and meaningful engagement of persons with disabilities in decision-making processes in both areas of work. By doing so, both initiatives will concretely contribute to the implementation of the ASEAN Enabling Masterplan 2025: Mainstreaming the Rights of Persons with Disabilities.

OBJECTIVES

11. The overall goal of the webinar series is to raise awareness on disability inclusive analysis and approaches in responding to and recovering from the COVID-19 pandemic, in order to identify pathways to mainstream the rights and promote the welfare of persons with disabilities pursuant to the implementation of the ASEAN Enabling Masterplan 2025: Mainstreaming the Rights of Persons with Disabilities. Specifically, the objectives are as follows:
 - a. For Webinar 1: *ASEAN Web Forum on Disability-Inclusion and COVID-19: Engaging Persons with Disabilities for Effective Response and Recovery*, to identify policy gaps challenges and opportunities in addressing the needs of persons with disabilities in the context of COVID-19;
 - b. For Webinar 2: *ASEAN Web Forum on Disability-Inclusion and ASEAN Economic Integration: Challenges and Opportunities for Persons with Disabilities*, to locate disability-inclusion in the ASEAN economic integration agenda, and identify good practices from

both public and private sectors on the inclusion of persons with disabilities in the context of the COVID-19 response and recovery ; and

- c. For Webinar 3: *ASEAN Web Forum on Disability-Inclusion, Smart Cities, and ASEAN Connectivity*, to introduce disability-inclusion perspectives and analysis in ASEAN's ongoing initiatives on promoting smart cities, sustainable urbanisation and strengthening ASEAN Connectivity.

EXPECTED OUTCOMES

12. Through the conduct of the webinars, the following outcomes would be realised:

- a. Accelerate the implementation of the ASEAN Enabling Masterplan 2025: Mainstreaming the Rights of Persons with Disabilities, through increased awareness and identification of approaches to introduce and integrate disability-inclusion in the work of relevant ASEAN sectoral bodies;
- b. Identify potential areas of partnership, including the identification of potential direct engagements on integrating disability-inclusion perspectives in ASEAN's agenda on economic integration, smart cities, and connectivity; and
- c. Strengthen collaboration with between ASEAN sectoral bodies and organisations of persons with disabilities, and explore ways to institutionalise regular interaction to ensure sustainability.
