The annual celebration of the National Biotechnology Week (NBW) was signed into law through Presidential Proclamation (P.P.) 1414 by then President Gloria Macapagal Arroyo on November 9, 2007. The P.P. 1414 was tasked the Departments of Agriculture (DA), Education (DepEd), Health (DOH), Interior and Local Government (DILG), Science and Technology (DOST), Trade and Industry (DTI), Commission of Higher Education (CHED), and DENR to craft a meaningful celebration that will showcase biotechnology. Since then, DENR along with the said agencies have been able to enlighten target groups on the benefits and safe application on biotechnology and its products for the country's food security, equitable access to health services, sustainable and safe environment, and industry development.

As DENR takes its turn to be the Chair of the 16th NBW Inter-Agency Committee (IAC), the department shall spearhead the planning, implementation, and assessment of all NBW activities for the Year 2020. The celebration of the 16th NBW will be on 23-27 November 2020.

In celebration of the said event, agency activities related to biotechnology are solicited for inclusion in the week-long program. Since the general public could not be taken to a physical venue where the exhibits will be displayed and lectures will be held, virtual platforms will be maximized to achieve better engagement with the public. The exhibits, webinars, and other activities of all participating departments and partner agencies will run for the whole duration of the NBW 2020. Contributions of biotechnology to health, agriculture, education, economy and environment will be highlighted through various media.
