The Biodiversity Management Bureau (BMB), together with the ASEAN Centre for Biodiversity - Biodiversity Conservation and Management of Protected Areas in ASEAN Project (ACB-BCAMP) will be holding a webinar series on Mainstreaming of Biodiversity in the Infrastructure Sector in November 2020. This activity aims to:
