

We find the termination of the plenary debates on the budget premature and inconsistent with the regular processes adopted and practiced by the House in the consideration of a general appropriations measure. It has effectively denied the members of the Minority the right to scrutinize the budgets of the government's line departments as part of our duty to fiscalize public funds that have been used and will be spent for government programs and projects.

The Minority Bloc of the 18th Congress is committed to carry on and fulfill our mandate as the representatives of our people. To this end, we will continue to tackle the issues concerning the various agencies as part of our efforts to ensure accountability in the utilization of public funds. The Minority shall proceed with its own parallel deliberations and submit and assert its own proposed amendments and other recommendations.

In line with this, we are inviting you to a Zoom meeting to discuss your 2021 budget on Monday, 12th October at 11 am. Kindly note that in the interest of transparency and to allow the public to participate in the process, we shall make these proceedings accessible to the media and the public via social media platforms.
