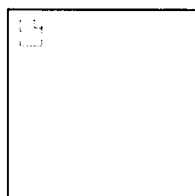
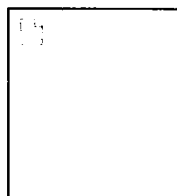

Dear **Secretary Nograles**:

First of all, we would like to thank you and your office for the active participation and support in the success of 2019 Dagyaw: Open Government and Participatory Governance Regional Town Hall Meetings last July to September 2019. This was conducted in 16 regions of the country and was participated in by 11,175 government and non-government stakeholders with representatives from 23 national government agencies who presented governmental plans and accomplishments and provided on-the-spot response and action to around 225 issues and concerns from the general public.

As the Participatory Governance Cluster (PGC) continues to spearhead the annual regional town hall meetings which were re-launched in 2019 pursuant to PGC Resolution No. 2 series of 2019 as Dagyaw: Open Government and Participatory Governance Regional Town Hall Meetings, these town hall sessions have evolved to adapt to the new normal. This year, through the Department of Budget and Management (DBM), Department of the Interior and Local Government (DILG), and Presidential Communications and Operations Office (PCOO), PGC has re-designed this activity and is re-branding it as **DAGYAW 2020: Virtual Town Hall Meetings**.

Dagyaw 2020 remains attuned to its main goal of building mutual trust between the government and its people by providing an open, neutral, and protected space for dialogue on key national and local issues and plans amidst the COVID-19 pandemic. Specifically, Dagyaw 2020 aims to: (1) conduct more transparent and inclusive town hall meetings through close collaboration with non-government sectors; (2) serve as a safe space for dialogues on pressing governance and operational issues at the national and local level; and (3) sustain the promotion of citizen participation in governance, despite the challenges posed by the pandemic, through the facilitation of digital conversations between the people and the government.

With the help of the non-government co-conveners, Right 2 Know Right Now (R2KRN) Coalition and Caucus of Development NGO Networks (CODE-NGO), the National Technical Working Group (NTWG), composed of the DILG, DBM and PCOO, came up with the Dagyaw People's Agenda — a list of eight (8) topics that will serve as the

main points of conversation for each of the 8 Dagyaw episodes at the National Level. The final list of topics went through a transparent and well-documented process where it was vetted by various non-government coalitions to uphold inclusion and political efficacy and co-governance. The same process will be followed at its regional implementation through the Regional TWGs as counterpart of the NTWG.

In view of the foregoing, the PGC respectfully requests for the Cabinet Secretary's endorsement of this activity to the Economic Development, Infrastructure, Human Development and Poverty Reduction, Security, Justice, and Peace and Climate Change Adaptation, Mitigation, and Disaster Risk Reduction Clusters for their support and participation in the Dagyaw 2020 activities.
