PROCLAMATION No. 829

DECLARING THE PERIOD FROM NOVEMBER 10 â€" 16 OF EVERY YEAR AS "DEAF AWARENESS WEEKâ€

WHEREAS, the deaf, a vital segment of our society, can be transformed into a significant force in the efforts for national development; and

WHEREAS, consistent with the foregoing, there is need to focus public awareness on deafness, its prevention and rehabilitation.

NOW, THEREFORE, I, CORAZON C. AQUINO, PRESIDENT OF THE PHILIPPINES, by virtue of the powers vested in me by law, do hereby declare NOVEMBER 10 to 16 of every year as "Deafness Awareness Week" under the auspices of the Philippine Institute for the Deaf and the Philippine School for the Deaf and other concerned organizations.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.

This has reference to the forthcoming celebration of the 29th Deaf Awareness Week that will be commemorated on November 10-16 this year under the joint auspices of the Philippine Institute of the Deaf (PID), Philippine School for the Deaf (PSD) and this Council pursuant to Proclamation No. 829 S. 1991 titled "Declaring November 10-16 of Every Year as Deaf Awareness Week".
