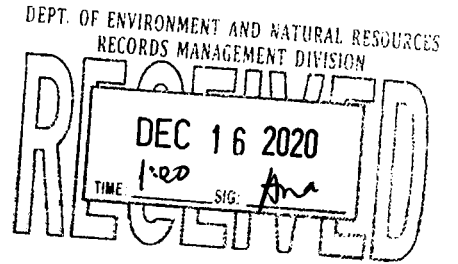

CREATING AND DESIGNATING A BUILDING AND THE PARCELS OF LAND, UPON WHICH IT STANDS, LOCATED IN BARANGAY MAYAMOT, MARCOS HIGHWAY, ANTIPOLO CITY, RIZAL AS A SPECIAL ECONOMIC ZONE (INFORMATION TECHNOLOGY CENTER), PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, **RODRIGO ROA DUTERTE**, President of the Republic of the Philippines, do hereby create and designate a building to be known as the **East Gate Business Center**, with a gross floor area of **Twenty-One Thousand Five Hundred Eighty-One and Eighty Hundredths square meters (21,581.80 m²)**, and the parcels of land, upon which the building stands, located in Barangay Mayamot, Marcos Highway, Antipolo City, with an area of **Five Thousand Seven Hundred Five square meters (5,705 m²)**, more or less, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, PEZA Board of Directors Resolution No. 00-411 (s. 2000), as amended by Resolution Nos. 11-066 (s. 2011), 15-240 (s. 2015) and 17-472 (s. 2017), and Resolution No. 18-178 (s. 2018), as a Special Economic Zone (Information Technology Center), as defined by the following technical descriptions:
