This refers to the letter of Assistant Secretary Junever M. Mahilum-West, Office of ASEAN Affairs, DFA dated 10 February 2021 calling for nominations for ASEAN Prize 2021.

The ASEAN Prize recognizes inspiring achievements and exemplary contributions of an individual or organization in fostering the ASEAN identity, promoting the ASEAN spirit and championing the ASEAN way. ASEAN Prize nominees should have exceptional merit in contributing to the following designated focus areas, taking into account ASEAN's theme this year, "We Care, We Prepare, We Prosper", as designated by the ASEAN Chair, Brunei Darussalam:

- a. Outstanding collaboration between ASEAN Member States (AMSs);
- b. Outstanding collaboration between ASEAN and the world;
- c. Outstanding people-to-people engagement among AMSs;
- d. Outstanding economic integration and promotion of standards between AMSs; or
- e. Other outstanding contributions to ASEAN Community Building.

To be eligible, the nominee must be a Filipino citizen or an organization created or led by the Philippines. The nominee must show his/her or the organization's verifiable achievements in promoting intra-ASEAN collaboration and the impacts that have been made on ASEAN. The nominee should also share his/her/organization's future plans in continuing the work after winning the Prize. In addition, the nomination should be submitted by at least one reference as the ASEAN Prize does not accept self-nomination.

Recipient will be presented during the 54<sup>th</sup> ASEAN Ministerial Meeting in Bandar Seri Begawan, Brunei Darussalam in August 2021 with ASEAN Prize Trophy and a cash prize of US\$20,000. The deadline for submission of nomination to the National Focal Point is on 21 April 2021.
