

THE 23RD OF MARCH 2021 VIA ZOOM

Committee Chairman Allen Jesse C. Mangaoang (L., Kalinga) presided over the public hearing on House Resolution 309, entitled: *“A Resolution Urging the Proper Committee of the House of Representatives to Conduct an Investigation In Aid of Legislation On the New Centennial Water Source-Kaliwa Dam Project (Ncws-Kdp) and Its Alleged Anomalous Award to China Energy Engineering Co. Limited”*. In attendance were Reps. Carlos Isagani T. Zarate and Eufemia C. Cullamat (PL, BAYAN MUNA), France L. Castro (PL, ACT-TEACHERS), John Marvin C. Nieto (3rd, Manila), Maximo Y. Dalog, Jr. (L., Mountain Province); and resource persons from the National Commission on Indigenous Peoples (NCIP), including its regional offices in Region IV-A and its Rizal provincial office, Quezon Provincial Office, Sangguniang Panlalawigan ng Rizal, China Energy Engineering Construction, Ltd. (CEEC), Department of Public Works and Highways (DPWH) Region IV-A, Commission on Audit (COA), Department of Environment and Natural Resources (DENR), DENR Forest Management Bureau (DENR-FMB), Department of Finance, Provincial Government of Rizal, Local Government of Tanay, Rizal, Local Government of Teresa, Rizal, the Metropolitan Waterworks and Sewerage System (MWSS), Indigenous Peoples Mandatory Representative (IPMR) Thelma P. Aumentado, Pambansang Kilusan ng mga Samahang Magsaaka (Pakisama), Philippine Movement for Climate Justice (PCMJ), the Freedom From Debt Coalition, and Sanlakas; as well as several ICC/IP leaders and various media outlets.

DISCUSSION:

1. The NCIP stated that the process of free, prior, and informed consent (FPIC) is still ongoing. The Chair raised the question as to why the project was allowed in the first place, as the FPIC, in the form of a memorandum of agreement (MOA), is a condition precedent to any undertaking involving ICCs/IPs. Rep. Zarate asked that preliminary reports of the ongoing FPIC process be furnished to the Committee Secretariat.
2. The MWSS has already submitted position papers on HRs 15 and 309 (both on the Kaliwa Dam project), and stated that the anomalies found are based on audits done by COA. MWSS also stated that it does not rely on funding from the government, but on funds from water tariffs paid by its users in Metro Manila.

3. IP leader Marcelino Tena raised the issue of Php 20 million paid to some ICC/IP groups, which caused the divide among the ICC/IP leaders. He also said that the community's decision-making should lie with the indigenous political structure (IPS), but their IPS has not yet been accredited. He also said that out of six (6) consultations held with the communities, five (5) of them did not have FPIC.
4. IPMR Aumentado stated that the Php 20 million was not a bribe, as insinuated. She also said that the IPS was indeed not yet accredited, but the accreditation papers are already with the NCIP.
5. The Provincial Government of Rizal recognizes that the importance of government development projects, but this must be balanced with care of the environment. It also stated that it was never furnished with any documents regarding the Kaliwa Dam project.
6. IP leader Ma. Clara Dullas of the Kababaihang Dumagat ng Sierra Madre stated that they passed a resolution asking for the cluster meetings, and submitted this resolution to the NCIP, but there has still been no action on NCIP's part. The Chair then asked the NCIP to furnish them as well as the Committee with the minutes of the cluster meetings. Dullas also said that the original IPS had already been validated, but now the IPS is no longer recognized.
7. The NCIP acknowledged that although there are many who are against the Kaliwa Dam project, it does not classify the ICCs/IPs as "pro-dam" or "anti-dam". It also clarified that the Php 20 million represented MWSS's commitment, and that the sacred places of the ICCs/IPs were respected and taken into consideration.
8. The NCIP also said that for the ICCs/IPs in Quezon, the MOA is currently being drafted. For the ICCs/IPs in Rizal, the negotiations are already done, and there is already a draft of the MOA, which will then be reviewed by MWSS and NCIP lawyers before presenting it to the communities. NCIP also stated that it is open to being investigated regarding its deficiencies with the FPIC.
9. Rep. Zarate stated that the timing of the release of the Php 20 million made it seem like "padulas" or grease money, which the NCIP denied. He also said that even the LGUs have issues about the project, and that the ICCs/IPs are split over the issue. He said during the construction of the Pililla windmills, most of the ICCs/IPs were for the project, and were included in the discussions. However, for the Kaliwa Dam project, the ICCs/IPs that were against the project were excluded from discussions.
10. The Freedom From Debt Coalition asked how the Notice to Proceed was issued when it was clear that the FPIC process was not yet consummated, echoing the sentiments of the Chair when he said that the project shouldn't have gone any further without the FPIC.
11. The MWSS said that the winning contractor, the CEEC, needed to do a detailed engineering design, and in order to do that, it needed to survey. The Chair pointed out that even the mere act of conducting a survey needed an FPIC.
12. The MWSS also said that the MOAs were already ready as of 2015, but could not proceed because according to the NCIP, an indigenous peoples' organization (IPO) should be registered with the Securities and Exchange Commission.
13. The Chair asked to see the paper trail in order to pinpoint the cause of delay. Conrado Vargas of the Save Sierra Madre Network added that aside from the paper trail, we would also need to see an audit of all cash flow.
14. The NCIP explained that the MOA with the ICCs/IPs in Quezon was for the Sumag River Diversion Project, wherein the Php 20 million was demanded by the ICCs/IPs as a "disturbance fee" (but listed in the MOA as a "cultural fee"), to be spent according to their Community Royalty Development Plan. The Chair asked the NCIP to furnish this Committee with a copy of that MOA.
15. The PMCJ said that one important requirement was that cultural issues should be resolved first, and this resolution would be noted in the environmental impact statement (EIS). It also said that in the case of the Kaliwa Dam project, the Environmental Compliance Certificate (ECC) was issued with incomplete information in the EIS, a clear lack of compliance, and also did not specify how the project's environmental impact would be reduced to residual levels. The Chair asked the PMCJ to submit a copy of its environmental study to the Committee.
16. Mr. Vargas raised the issue of funding, saying that the Kaliwa Dam project used to be a public-private partnership (PPP), but then it turned out that 85% of the Php 12.5 billion fund for the project would be loaned from China, while the rest of the amount would be shouldered by the taxpayers.

17. Ms. Dullas raised the issue of the access road, which was a new road, not an old road that was repaired and improved. The access road was said to be for tourism, but even its construction did not go through the FPIC process.
18. Mr. Tena said that during last year's lockdown, some ICCs/IPs weren't allowed to enter their ancestral domain, whereas the Chinese contractors were already beginning construction.
19. The DPWH clarified that the access road was composed of two (2) lanes and was sixteen (16) meters wide, including the canal, and that it was not specified that it was for tourism. The Chair asked the DPWH to furnish a copy of the budget and expenditures of the access road construction to the Committee.

DECISIONS MADE/PROPOSED INTERVENTIONS


1. The NCIP needs to furnish the Secretariat with the following: a) copies of the preliminary reports of the ongoing FPIC process; b) an updated report on the status of the FPIC process; c) the minutes of the cluster meetings, a copy of which should also be sent to the requesting party the Kababaihang Dumagat ng Sierra Madre; and d) a copy of the MOA for the Sumag River Diversion Project, before the Php 20 million was downloaded to the ICCs/IPs.
2. MWSS needs to furnish the Secretariat with the following: a) a breakdown of expenses of the Php 20 million; and b) the paper trail to explain the delay in the FPIC process.
3. The PMCJ needs to furnish the Secretariat a copy of its environmental study on the Kaliwa Dam project.
4. The DPWH needs to furnish the Secretariat with a copy of the budget and expenditures of the access road construction.

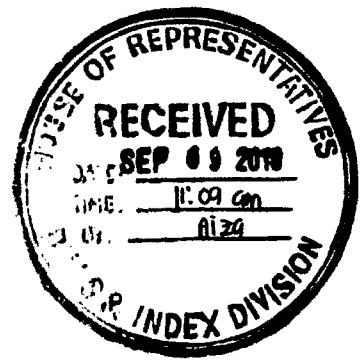

HOUSE RESOLUTION No. 309

Introduced by Representatives Fidel F. Nograles

A RESOLUTION
URGING THE PROPER COMMITTEE OF THE HOUSE OF
REPRESENTATIVES TO CONDUCT AN INVESTIGATION IN AID OF
LEGISLATION ON THE NEW CENTENNIAL WATER SOURCE-
KALIWA DAM PROJECT (NCWS-KDP) AND ITS ALLEGED
ANOMALOUS AWARD TO CHINA ENERGY ENGINEERING CO.
LIMITED

Whereas, the New Centennial Water Source Project- Kaliwa Dam Project (NCWSP-KDP) ("the Project") is proposed to be developed in order to address the National Capital Region's need for adequate and reliable water supply;

Whereas, it was revealed in a Commission on Audit (COA) Memorandum dated 10 June 2019 and released to the public on 18 July 2019, that the Metropolitan Waterworks and Sewerage System (MWSS) Technical Working Group (TWG) shortlisted three (3) Chinese contractors for the bidding of the Project even if all of them lacked prequalification requirements;

Whereas, contrary to MWSS protocol, the date of completion for past projects by the firms, including *China Energy Engineering Co. Limited*, the winning contractor, was not specified;

Whereas, *China Energy Engineering Co. Limited* and Consortium of *Guandong Foreign Construction Company Limited, Guandong Yuantian Engineering Company* did not indicate the completion date of construction projects they have undertaken;

Whereas, the Notice of Award (NOA) was already issued to *China Energy Engineering Co. Limited* last October 11, 2018, but the Notice to Proceed (NTP) is yet to be issued pending the submission of the required documents;

Whereas, *China Energy Engineering Co. Limited* already conducted preliminary project activities even if the loan agreement had not yet taken effect;

Whereas, aside from the alleged irregularities in the vetting procedure, there also exists various oppositions questioning the Project, including its potential damage to the environment and the displacement of indigenous peoples;

Whereas, the Department of Environment and Natural Resources (DENR) has earlier stated that the Environmental Compliance Certificate (ECC) has not been released due to the lack in documentation requirements, such as the Free, Prior and Informed Consent (FPIC) of Indigenous Peoples occupying the area;

Whereas, it is imperative that an investigation on the *vetting procedure* and the oppositions to the Project be conducted so that the legislature may enact the necessary measures to ensure the integrity of public bidding and faith in public works and infrastructures as respecting human rights and the environment;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the House of Representatives to direct the proper Committee to conduct an

investigation in aid of legislation on the New Centennial Water Source-Kaliwa Dam Project and the alleged anomalous award to China Energy Engineering Co. Limited.

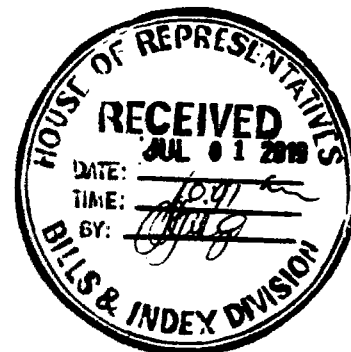

RESOLUTION
URGING THE COMMITTEE ON NATURAL RESOURCES TO CONDUCT AN
INVESTIGATION, IN AID OF LEGISLATION, ON THE ALLEGED WATER CRISIS
AND THE REVIVAL AND EFFECTS OF THE CONSTRUCTION OF THE KALIWA
DAM AND LAIBAN DAM PROJECTS

WHEREAS, in a media briefing on October 2016, Maynilad Water Services Inc. President and Chief Executive Officer Ramoncito Fernandez warned of an alleged approaching "water crisis" in Metro Manila, unless the government could find another source of water to supplement the Angat reservoir system. Maynilad is one of the private water service providers of the MWSS and whose 83.96% of shares are owned by a joint venture between Metro Pacific Investments Corporation (MPIC) and DMCI Holdings, Inc. (DMCI);

WHEREAS, the construction of the Kaliwa Dam was then floated as the solution to the alleged "looming water crisis" by the Maynilad CEO. The P12.2 billion Kaliwa Dam, dubbed as the New Centennial Water Source (NCWS), is a project to be funded by China through an Official Development Assistance (ODA). The Kaliwa Dam is projected to increase water supply to Metro Manila by 600 million-liters-a-day (MLD.) Still under the NCWS, the Kaliwa Dam will then be connected and expanded by the construction of a larger Laiban Dam Project, pegged to provide 1,800 more MLD to Metro Manila;

WHEREAS, the dam project and reservoir is located in the uplands of Quezon and Rizal. The construction site of the project is located within the zone of two active tectonics – the Philippine Fault Zone and the Valley Fault System.

WHEREAS, Proclamation No. 573 s. 1968 has already declared the Kaliwa Watershed Forest Reserve, in which the Kaliwa dam is to be constructed. Moreover, Proclamation No. 1636 s. 1977 declared a portion of the watershed as National Park and Wildlife Sanctuary.

WHEREAS, the construction of Kaliwa dam will undoubtedly threaten wildlife such as the following endemic species: Endangered Northern Philippine Hawk-eagle, the Philippine Brown Deer, the Philippine Warty Pig, the Vulnerable Northern Rufous Hornbill, the Critically Endangered Philippine Eagle, and restricted-range birds of the Luzon Endemic Bird Area.

WHEREAS, the Kaliwa dam project will affect some 10,000 indigenous Dumagat and Remontado indigenous peoples and 11,000 farmers. The proposal of a mega dam project in the Sierra Madre Range goes as far back in the 1970s, but was consistently opposed by the Remontado and Dumagat indigenous peoples, peasants and environment activists. The decades-long opposition is a fight of land and life for the indigenous peoples, and was even defended by blood. In 2001, a prominent Remontado leader, Nicanor delos Santos, who was also the Vice Chairperson of Bigkis at Lakas ng Katutubo sa Timog Katagalugan or Balatik, was killed in cold blood in December 9, 2001. Delos Santos, who was then preparing for the Dumagat-Remontado contingent to the Human Rights Day commemoration in Manila, was gunned down in a marketplace in Antipolo City by alleged members of the Task Force Panther under the 2nd Infantry Division of the Philippine Army. The indigenous peoples viewed this brutal killing as an attempt to silence the indigenous peoples fiercely defending their lands;

WHEREAS, the Duamagat and Remontados leaders questioned the Free, Prior and Informed Consent process of the National Commission on Indigenous People (NCIP) for they didn't received any copies of the relevant documents from the MWSS.

WHEREAS, the indigenous peoples assert that their protest versus the dam project is not only an issue of ancestral land rights but resistance against the commercialization of water resources. The Water for the People Network (WPN), a campaign network promoting water-related struggles, supports the claim of the indigenous peoples resisting the Laiban Dam and Kaliwa Dam construction. According to the WPN, there is no need for the construction of additional large dams in Sierra Madre, citing data that 15% to 60% of water from current water sources, the Angat and Umiray dams, are lost to leakages. Maynilad alone loses 1,400 MLD of water in 2010;

WHEREAS, on May 9, 2019, Makabayan party-lists filed a petition before the Supreme Court questioning the constitutionality of the loan agreement between China and Philippines for the construction of Kaliwa dam. The Makabayan coalition, along with other organizations, coalition and advocates, such as STOP Kaliwa dam coalition and Supreme Court Senior Associate Justice Antonio Carpio, questioned the following provisions of the loan agreement:

- a) on Article 5.7, it is agreed upon that the Philippines or any of its assets, unless prohibited by the laws and public policies, are not entitled to any right of immunity on the grounds of sovereign or any legal process
- b) on Article 8.1, the Philippines waived any immunity on the grounds of sovereign
- c) on Article 8.4, it is agreed upon that the agreement shall be governed by and construed in accordance with the laws of China
- d) on Article 8.5, it is agreed upon that Hong Kong International Arbitration Centre will conduct the arbitration in case of dispute
- e) on Article 8.9, it is stated that the terms, conditions and the standard of fees of loan agreement will be confidential. The loan agreement was later on released by the Department of Finance to the public due to the public outcry for transparency and accountability.

WHEREAS, there is a clear issue of conflict of interest in the Maynilad's call for the immediate construction of these bulk water projects. The bogey of an unfounded "water crisis," should not be dangled to justify the massive dislocation of indigenous peoples and peasants and enormous environmental damage;

NOW THEREFORE, BE IT RESOLVED that the House of Representatives through the Committee on Natural Resources to conduct an investigation, in aid of legislation, on the alleged water crisis and the revival and effects of the construction of the Kaliwa Dam and Laiban Dam Projects.


