PROCESSING OF TERMINAL LEAVE BENEFITS

This is to inform you of the letter dated 09 March 2021 of Director Cristina B. Clasara of the Department of Budget and Management (DBM) relative to the processing of terminal leave benefits.

Second paragraph of the said letter states:

"With the reduction in the FY 2021 Pension and Gratuity Fund, may we suggest that the subject request be charged against the agency's available Personnel Services (PS) allotment released under the program/activity/project, Administration of Personnel Benefits (APB). In case the APB allotment of the DENR-OSEC is insufficient, any available PS allotment within the agency may be utilized for the purpose, in accordance with Section 46 (Funding of Personnel Benefits) and Section 47 (Appropriations for Personnel Services) of the General Provisions, FY 2021 General Appropriations Act. Moreover, the corresponding cash requirement may be charged against the available cash balance of the agency using the Common Fund System."

In view thereof, the payment of terminal leave benefits of employees shall be charged against the available PS allotment of the respective Regions/Bureaus.
