PROCLAMATION NO. 1151

**CREATING AND DESIGNATING SEVERAL PARCELS OF LAND, LOCATED ALONG RAJAH SIKATUNA AVENUE, BARANGAY DAMPAS, TAGBILARAN CITY, BOHOL, AS AN INFORMATION TECHNOLOGY PARK, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748**

Pursuant to the powers vested in me under Republic Act (RA) No. 7916 or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, **RODRIGO ROA DUTERTE**, President of the Republic of the Philippines, do hereby create and designate several parcels of land located along Rajah Sikatuna Avenue, Barangay Dampas, Tagbilaran City, Bohol, as an Information Technology Park, to be known as the **Tagbilaran Uptown IT Hub**, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, Resolution No. 00-411 (s. 2000), as amended by Resolution No. 04-295 (s. 2004), and Resolution No. 17-227 (s. 2017), as amended by Resolution Nos. 18-277 (s. 2018) and 19-440 (s. 2019), with an aggregate area of **Thirteen Thousand Eight Hundred Sixty-Six square meters (13,866 m<sup>2</sup>)**, more or less, as defined by the following consolidated technical description:
