

From the National Archives of the Philippines (NAP) and the Presidential Communications Operations Office (PCOO), Mabuhay!

The NAP and PCOO respectfully invite your agency/department to participate in a series of inaugural events for the roll-out of the Electronic Records Management Policy (ERMP) for the Philippines. We have just successfully concluded our rollout event in the Visayas on 5 May 2021 and in the National Capital Region (NCR) with selected agency-participants on 9 June 2021. There will be four (4) more separate rollouts for NCR, Luzon, Western Visayas, and Mindanao this year. These will be held in two identical four-hour online sessions with the first session beginning at 8am. The schedules and the offices to be invited are as follows:

- a. June 22, 2021 (morning session)
 June 22, 2021(afternoon session)
- NCR (Departments & attached agencies)
- NCR (Departments & attached agencies, LGUs, Schools, Universities and Water Districts
- b. August 17, 2021 (morning session) Western Visayas offices August 17, 2021 (afternoon session) – Northern Luzon offices
- c. September 14, 2021 (morning session) Central Luzon offices September 14, 2021 (afternoon session) — Southern Luzon offices
- d. October 12, 2021 (morning session) Northern Mindanao offices
 October 12, 2021 (afternoon session) Eastern and Southern Mindanao offices

Please note that we are requesting the attendance of two (2) senior representatives for each of the rollout sessions who directly supervise your Records Management Program in your offices concerned. Secretary Martin Andanar and Undersecretary Kristian Ablan are expected to address the events.

The NAP, under R.A. 9470, is mandated to establish policies and guidelines for electronic records for all government agencies. The newly created ERMP, which was developed in partnership with the PCOO, provides the government sector guidance for the shift from traditional paper records management to an electronic regime. Moreover, this new

protocol complies with the President's instruction to embrace electronic governance and take advantage of the advances in technology to enhance service delivery to the public.

We hope to receive your positive response along with the names, emails, and regional offices of the attendees by 16 June 2021 for the June 22 sessions and by June 30 for the sessions of the rest of the year.
