Further, the system is still fully-functional/operational as basic repository of official electronic report involving illegal logging and wildlife cases. The Department would like to have access on all field reports, any time and anywhere and get uniform and standard data on apprehension, seizure, and confiscation of undocumented forest products including conveyances, tools and implements including status of criminal complaints/ cases. Currently, the process of consolidating field reports is manually done which is simply tedious and time consuming. Besides, field reports come in different formats, different units of work measurement (UWM), no remarks on the status, etc., that somehow contributes to discrepancies in the reports.

In view hereof, in order to rectify this, you are hereby instructed, effective immediately, to continue using the "E-Filing and Monitoring System (e-FMS) for Illegal Logging and Illegal Wildlife Cases" until such time that a new system is adopted.

For any problems encountered in activating "e-FMS" accounts, you may coordinate with the DENR Knowledge and Information Systems "e-FMS" administrator in the Department.
