2. Economic resources destined to pay, finance or invest in the formulation and execution of actions related to international environmental policy; and
3. Actions carried out with civil society groups or in cooperation with other countries, which promote the agreed commitments.

We also respectfully recommend that your Office include the implementation of specific environmental programs, pursuant to international environmental law and MEAs, that address issues that cut across the destruction of marine ecosystems and biodiversity in PH territorial waters.
