SUBJECT : **INVENTORY OF ALL ADMINISTRATIVE CASES PENDING BEFORE THE DENR AND CRIMINAL CASES PENDING BEFORE JUDICIAL COURTS INVOLVING APPREHENDED, CONFISCATED AND/OR SEIZED FOREST PRODUCTS AND CONVEYANCES**

During the DENR Management Committee (ManCom) Meeting held last 05 July 2021, as part of the directive of Secretary Roy A. Cimatu to intensify forest protection in the Philippines, he instructed that "(t)he Legal Affairs Service and the Regional Offices should speed up the administrative adjudication proceedings for apprehended forest products to show perpetrators that we really mean business."

In line with this, you are hereby directed to conduct and submit an inventory of all administrative cases pending in your respective offices, and criminal cases pending before the courts, involving apprehended, confiscated and/or seized forest products and conveyances, subject of violation of Presidential Decree No. 705, as amended. The inventory must be in accordance with the template attached hereto as Annex "A". **Kindly submit a copy of the inventory via e-mail at legal.lpd@denr.gov.ph on or before 30 July 2021**, and a physical copy of which shall likewise be sent to this Office.
