Dear Undersecretary Leones:

Executive Order (EO) No. 138, s. 2021 mandates the preparation of Devolution Transition Plans (DTPs) by national government agencies (NGAs) and local government units (LGUs) to facilitate transition towards full devolution starting FY 2022 in light of the implementation of the Supreme Court Ruling on the Mandanas and Garcia petitions

To guide LGUs in the preparation of their DTPs, the Department will be conducting a series of activities at the national and sub-national levels to cascade guidance and facilitate coaching of LGUs on the preparation of their respective DTPs.

A two-day National Orientation will be conducted on **29-30 July 2021 via Zoom** to orient target participants on the prescribed processes and templates for the preparation of LGU DTPs to jumpstart the LGU DTP activities at the field level. Expected participants include representatives from the DILG Regional and Provincial Offices; Central and Regional Office representatives of partner Public Financial Management (PFM) Oversight Agencies to include the DBM, DOF and NEDA; Central and Regional Office representatives of selected sector agencies; Regional Development Council (RDC) sectoral representatives, and selected Local Planning and Development Coordinators (LPDCs).

In line with this, may we request you or your representative to present during the first day (29 July 2021, afternoon session) the: (i) general contents of the DENR DTP; and (ii) specific services and functions applicable to the region/province selected as this shall be used in the simulation workshops later in the activity. We will inform you of the selected region and province on or before 27 July 2021.

May we also request the participation of a representative from each of the DENR Regional Offices (except BARMM) since they will subsequently be invited as resource speakers to re-echo the same presentation at the regional level orientations on the preparation of LGU DTPs.




