**POLICY REFORMS** 

This refers to the Memorandum dated August 4, 2021 from the Undersecretary for Policy, Planning and International Affairs, forwarding the email dated August 2, 2021 from Ms. Patrizia L. Garcia of the Office of Congressman Alan Peter S. Cayetano, requesting for information on the DENR's priority programs, projects, policy reforms, among others.

The Office of Cong. Cayetano seeks to formulate policies to support the plans and programs of various government agencies, with the objective of helping the country recover from the economic losses across all industries and improve public services.

According to the DENR Legislative Liaison Office (LLO), four (4) priority ENR bills are currently being tackled in Congress, namely, the Environmental Protection and Enforcement Bureau (EPEB) bill, Sustainable Forest Management (SFM) bill, bill amending/revising Republic Act (RA) No. 9147 or the Wildlife Resources Conservation and Protection Act, and the Boracay Island Development Authority (BIDA) bill. Aside from these proposed measures, may we inquire whether your respective office has proposed policy reforms/draft bills which may help in the country's economic recovery due to the pandemic and improve public services.

In this regard, may we request for the submission of your inputs to the PPS-Policy Studies Division on or before August 13, 2021. You may email your inputs at psddivision@gmail.com or policy@denr.gov.ph.
