### Course Brief

# **Event Description:**

The theme for this year's Public Sector HR Symposium is "Transforming Government Agencies Into Smart Organizations: Honing Resilient and Future-Ready Public Servants."

Driven by passion for public service excellence amidst the challenges caused by the pandemic and in adapting to emerging technologies, this year's symposium will focus on the strategic role of Government Leaders and HR Practitioners in transforming government agencies into smart organizations. It includes introducing innovative approaches in leading change and shaping people strategies to develop resilient and future-ready public servants to ensure continued delivery of efficient and effective public service.
