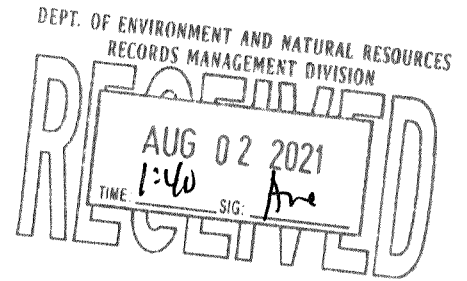

PROCLAMATION NO. 1191

CREATING AND DESIGNATING SEVERAL PARCELS OF LAND LOCATED IN BARANGAYS LINMANSANGAN AND CANARVACANAN, BINALONAN, PANGASINAN, AS A SPECIAL ECONOMIC ZONE TO BE KNOWN AS NORTHLUZON AERO INDUSTRIAL PARK, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, otherwise known as the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, **RODRIGO ROA DUTERTE**, President of the Republic of the Philippines, do hereby create and designate several parcels of land located in Barangays Linmansangan and Canarvacanan, Binalonan, Pangasinan, as a Special Economic Zone, to be known as **NorthLuzon Aero Industrial Park**, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, and PEZA Board of Directors Resolution No. 20-163 (s. 2020), with an aggregate area of **Two Hundred Sixty-One Thousand Six Hundred Sixty square meters (261,660 m²)**, more or less, as defined by the following technical description:
