6. Report on the impact of the lockdowns in the air quality and pollution level in Metro Manila and other major cities;
7. Plans and strategies undertaken by the department concerning plastic wastes and disposal of hospital wastes used for COVID-19 treatment;
8. Report on the completed commissioning, upgrading, retrofitting and rehabilitation of the La Mesa Water Treatment Plant (LMTP) of Maynilad Water Services;
9. Approved FY 2021 Corporate Operating Budget of corporations particularly the Laguna Lake Development Authority (LLDA) and other corporations under the DENR including the financial statements for the last three years; and
10. Other matters which will help the Committee in the deliberations on the FY 2022 proposed budget.
