Pursuant to Office of the President Memorandum Circular No. 90 and in observance of the 29th National Family Week, which starts today, DENR employees and persons hired under contract of service are hereby authorized to leave work after 3:30 P.M. today, 27 September 2021.

Proclamation No. 60 s. 1992 declares every last week of September as Family Week. On the other hand, Proclamation No 326 s. 2012 declares the fourth Monday of September as *Kainang Pamilya Mahalaga* Day. Employees are allowed to leave early from work on the first day of the National Family Week to spend time with their families, especially to share meals together.

MEMORANDUM CIRCULAR NO. 90

Pursuant to Proclamation No. 60 (s. 1992), which declared the last week of September of every year as Family Week, and in order to afford government workers and their families time to celebrate, in their respective homes, the *Kainang Pamilya Mahalaga* Day pursuant to Proclamation No. 326 (s. 2012), work in government offices in the Executive Branch shall be suspended from 3:30 in the afternoon onwards on Monday, 27 September 2021.

However, those agencies whose functions involve the delivery of basic and health services, preparedness/response to disasters and calamities, and/or the performance of other vital services shall continue with their operations and render the necessary services.

This Office also encourages all government workers in the Executive Branch to fully support the Family Week Celebration prepared by the National Committee on the Filipino Family.

The suspension of work in other branches of government, in independent commissions or bodies, and in the private sector is encouraged so as to afford all Filipino Families the full opportunity to celebrate the 29th National Family Week.

This Circular shall take effect immediately.
